Executive Summary–Mason City/Clear Lake 2012

Careful thought and consideration have been put into assembling an agenda of the key issues pertinent to the future of North Iowa. The issues outlined in this booklet have been chosen based upon the benefit and impact each has on the future development of our county and have broad-based support.

ECONOMIC GROWTH & JOB CREATION

1) Water Treatment Plant Improvements—Mason City

The City of Mason City has implemented an aggressive program to provide the safest, most reliable system for providing clean water to citizens and businesses (and to the region in the event of a disaster.) Unfortunately, city utility rates are now among the highest in the state, creating a competitive disadvantage for recruiting additional food processors, bio-fuel manufacturers, and other large water users to the community. These high rates make it difficult for our existing manufacturers to compete within their corporations for increased volume and expansion opportunities. Research demonstrates that installation of a Pressure Sand Filtration System will increase the effectiveness of the current system, reduce chemical use at the plant, and save money.

REQUEST: \$2,080,000

2) Mason City Municipal Airport

Air service and continued investment in the infrastructure of the Mason City Municipal Airport continue to be a major priority for the North Iowa region. The Essential Air Service program ensures our region has access to commercial air service, and the Federal Airport Improvement Program enables our airport commission to complete important safety projects.

REQUEST:

- Support for EAS program at an overall funding level of \$210 million—which is sufficient
 to continue air service at all eligible communities without the addition of a local costshare program.
- Passage of a five-year reauthorization bill at \$3.5 billion funding level.
- AIP—maintain primary entitlements at 95%; authorize the use of AIP funds to develop revenue generating facilities at non-hub airports.
- Ensure adequate AIP funding is available to complete the Terminal Parking Lot Reconstruction Project.
- Provide full funding for the Contract Tower Program and the Small Community Air Service Grant Program.
- Fee Structure—increase Passenger Facility fee to \$7.50 and incorporate an index to inflation; maintain current fuel and ticket tax structure.

3) <u>Industrial Thoroughfare Widening—Mason City</u>

With increased industrial and vehicular traffic, safety is a growing concern on North Eisenhower Avenue and 12th Street NW. These thoroughfares provide access to some of Mason City's largest employers and manufacturers as well as tourists and citizens seeking health care services. The project includes widening Eisenhower Avenue and 12th Street NW as well as a key bridge replacement.

REQUEST: \$525,000 to complete Phase 1 (Design) of the project.

4) Renewable Energy Opportunities

North lowa has established itself as an energy hub. North lowans see the opportunity to build upon this reputation by attracting additional energy operations. The federal government can assist our efforts by providing incentives such as tax credits and tax rebates; increasing federal standards for renewable fuels; increasing funding for research and development; and perhaps most importantly, increasing the federal investment in energy transmission infrastructure.

REQUEST: Support for programs that expand the renewable fuels industry.

PUBLIC SAFETY

5) Construction of a Public Safety/City Services Complex—Clear Lake

The Clear Lake Police Department has requested funding for needed organizational improvements to ensure the health and safety of the police officers and the citizens they serve. The proposed project includes:

- Replacement of original dispatch equipment
- Incorporation of vehicle and pedestrian sally ports
- Safe Interview Rooms
- Holding Cells (currently non-existent)
- Locker Rooms
- Offices
- Squad Room
- Debriefing Room
- Public Lobby/Waiting Room (currently non-existent)

REQUEST:

Assistance in determining federal funding opportunities for this important project.

6) Flood Recovery/Storm Sewer Projects—Mason City

As a community that was severely affected by the 2008 floods, the need to control the collection of water run-off in an aging storm sewer system is apparent. Citizens currently pay a Storm Water Utility charge each month. These funds will be used for replacement and repair, but are not adequate

to complete the most urgent of the identified needs.

REQUEST:

- \$800,000 to install 5000' of storm sewer pipe to relieve street and localized flooding.
- \$1.5 million to replace 5000' of existing CMP storm pipe with RCP storm pipe. The
 deterioration of existing pipe has created sink holes in the street right-of-way. Spot
 repairs have proved ineffective.

7) National Flood Center

Currently, lowa is the only state with a flood center. This university-based flood center has the capability for real-time forecasting technology that can assist states and communities with flood preparation. The federal agencies that currently assist with flood forecasting and safety measures do not have the expertise of the lowa Flood Center.

REQUEST: Designation of the lowa Flood Center at the University of lowa as the National Flood Center. Provide funding for a national flood program that will enable states and communities to minimize flood losses through better prediction and protection methodology.
